

The YP Project:

Information & Referral Criteria for Professionals

The YP Project at the Jenkins Centre provides services relating to Young People Using Abuse: Adolescent to Parent Violence and Abuse (APVA), Child on Parent Abuse (COPA) or Intimate Partner Violence (IPV).

Young Person's Project Eligibility and Suitability Criteria				
Leicester City and County: IPV & APV for 10 to 18 years				
Exclusions:	Literacy & Comprehension: levels must be at minimum age of 10 years and no more than 2 years below their actual age. Where there is additional learning and physical disabilities that impact learning and			
	comprehension, this programme will not meet the needs of the young person. (If there is ADHD / Autism, the programmes may still be appropriate where the young person has appropriate literacy & comprehension levels; this will be advised following assessment).			
	Where a young person is currently being assessed by CAHMS or paediatrics for a possible diagnosis, referrals may not be accepted. Information must be provided relating to CAHMS/Paediatric involvement / referral.			

Please read the information below carefully.

Contact The YP Project should you have any queries relating to possible referral. Please note, if referral is accepted, it is part of our essential criteria that all referrers keep cases open to young person and/or family and/or victim during the initial intervention process.

Prior to being accepted on any intervention programme a YP Project Interventions Worker will complete a Suitability and Risk Assessment. This normally takes place over 2 sessions, although in some cases may require additional sessions.

PLEASE NOTE: We ask professionals NOT to include our interventions on a client's Child Protection Plan or Child in Need Plan. We are a voluntary service and therefore clients are not obligated to engage with us.

About the Programmes

1. Respect Young People's Toolkit:

The Respect Young People's Toolkit is aimed at young people aged 10 to 18 who are displaying abusive behaviours towards a parent /carer and is designed to be delivered to **just the** young person..

The Respect Toolkit is a comprehensive resource for the delivery of interventions using a range of therapeutic and practical tools to work with young people in relation to their abusive behaviours. The Respect Toolkit is normally delivered to young people in relation to IPV or APVA. This normally takes place over 10 to 12 weeks. The Young Person's Intervention worker will complete a comprehensive assessment and then develop an intervention plan based on the Toolkit and other bespoke interventions.

2. Bespoke Intervention:

Where Young People are using IPV or APVA, but the above programmes are not directly suitable the Young Person's Intervention Worker may design a bespoke intervention. This will only be agreed where there are other services actively supporting the young person.

Examples of where this may be appropriate are for young people involved with Youth Offending Service or a Looked After Child where the young person is currently engaged with interventions relating to those services or has historically completed similar interventions.

3. The YP Project Parenting Programme:

This programme is aimed at parents/carers who are experiencing abusive from their child/young person. The parenting programme is based on Non-Violent Resistance approach (NVR). The Programme takes place over 15 weeks of 1-2-1 support. The parent's Intervention worker will complete a comprehensive suitability assessment prior to any support taking place.
